

**NOTICE OF GENERAL ELECTION
CITY OF CHARLESTON
NOVEMBER 7, 2017**

The City of Charleston Municipal Election Commission hereby gives notice that the City of Charleston will conduct a General Election on Tuesday, November 7, 2017 to fill (6) six City Council seats for District 2, 4, 6, 8, 10 and 12; and (1) seat for Commissioner of Public Works. This is a nonpartisan, at large, municipal election conducted pursuant to SC Code of Laws § 5-15-62, nonpartisan and runoff method of election. No party affiliation shall be placed on the ballot.

Any Runoff Election will be held on Tuesday, November 21, 2017 at the precincts listed below.

Referendum Question

In order to assist with the acquisition, construction and equipping of safe and affordable housing for persons and families of low to moderate income, shall the City of Charleston be empowered to issue not exceeding \$20,000,000 of General Obligation Bonds?

The last day that persons may register to be eligible to vote in this election is Friday, October 6, 2017. If submitting a registration application by mail or fax, it must be postmarked no later than Saturday, October 7, 2017.

Registered voters who cannot vote in person may be eligible to vote by absentee ballot. Absentee ballots may be obtained from the Charleston County Board of Voter Registration and Elections office. At 9:00 a.m. on Election Day, the Charleston County Board of Voter Registration and Elections will examine absentee ballot return envelopes at the elections office, 4367 Headquarters Road, North Charleston, SC.

On Thursday, November 9, 2017 at 12:00 Noon, the **Municipal Election Commission** will hold a public hearing at the elections office, 4367 Headquarters Road, North Charleston, SC, to determine the validity of all ballots challenged in this election, and certify election results.

This Municipal Election will be conducted pursuant to S.C. Code § 7-13-710 pertaining to Photo ID requirements to vote.
